PURPOSE OF PRODUCT: TL CAL Plus is an AQUAMIZED™ Calcium supplement for foliar application, utilizing highly absorbable Calcium Acetate with supplemental Nitrogen from Calcium Nitrate and beneficial Kelp extracts of Ecklonia Maxima for field crops, fruit trees and green house crops to be used as a supplement to a balanced fertilizer program. Shake well or agitate before use.

DIRECTIONS FOR APPLICATION: Small fruit, berries, and vegetables apply a foliar application-1-4 quarts/acre in 10-250 gallons of water/acre pre bloom repeat applications every 7-14 days through early fruit development. Citrus apply a foliar application-4-8 quarts/acre in 10-250 gallons of water/acre pre bloom repeat applications every 7-14 days through early fruit development.
